SUBJECT: Adjustment to REACH REGULATION 1907/2006

The undersigned **ROBERTO TAMAGNINI** born in Castelnovo Sotto (RE) on 20.08.1967 residing in S. Ilario d'Enza (RE) Via Apollo 11, n.1 as legal representative of the company TEM Electric Motors Srl located in Castelnovo di Sotto (RE) Via Beretta, 1 – Vat no. IT 01978390357

declare:

TEM does not produce chemicals and does not import them in quantities greater than 1 ton/year.

Article 33 of the **REACH regulation n.1907/2006** obliges customers to declare the presence in their products of substances belonging to the SVHC list (provided for by article 59 of the aforementioned regulation) with a concentration higher than 0.1% by weight.

TEM does not intentionally introduce substances belonging to the SVHC list in its articles. As regards SVHC substances, subject to restriction (Annex XVII of the REACH Regulation) and substances subject to authorization (Annex XIV of the REACH Regulation) TEM relies on the declarations of its suppliers, without carrying out inspection activities; as a result, all the declarations received certify the absence or presence in a percentage of less than 0.1% of substances included in the Candidate List (SVHC), with the exception of **Lead (CAS No. 7439-92-1)**, which may be present in some metal alloys (e.g. high-speed steel, bronze, brass, tin and aluminium) in quantities greater than 0.1%; in this form it cannot be inhaled or ingested.

The danger may arise in the unintended use of the product such as mechanical processes or chemical processes that generate dust and/or fumes from the product itself. It is therefore recommended not to carry out these operations not foreseen for the product without adequate protection.

TEM will regularly inform customers of any new developments relating to the "REACH" provisions and the related Candidate List, regularly carrying out monitoring activities towards its suppliers.
