## PRIVACY POLICY OF THIS SITE

### WHY THIS NOTICE

This page describes how the site is managed with reference to the processing of personal data of its users.

This notice is given pursuant to [art. 13 of the legislative decree n. 196/2003 – Code regarding the protection of personal data di protezione dei dati personali](#) to those who interact with *web service* of **TEM ELECTRIC MOTORS s.r.l.** for the protection of personal data accessible electronically from the address: [www.tem-electric-motors.com](http://www.tem-electric-motors.com). The information is given only to the website of **TEM ELECTRIC MOTORS s.r.l.** and not to other web sites accessed via *link*.

The information is based on Recommendation n. 2/2001 that the European authorities established for the protection of personal data, gathered by the Group established in [Art. 29 of the Directive nr. 95/46/CE](#), adopted on 17 May 2001 to establish minimum requirements for collecting personal data *on-line*, and, in particular, the manner, timing and nature of the information that data controllers must provide to users when they connect to web pages, regardless of the purpose of the link.

### THE “DATA CONTROLLER”

Following consultation of this site may be processed data on persons identified or identifiable. The holder of this treatment is **TEM ELECTRIC MOTORS s.r.l.** via Beretta nr.1 – 42024 Castelnovo di Sotto (RE).

### DATA PROCESSOR

The Company TEM Electric Motors has been designated as controller in accordance with [article 29](#) of the Code regarding the protection of personal data, as responsible for the maintenance of the technological part of the site.

### PLACE OF DATA PROCESSING

Treatment related to the web services of this website take place in **TEM ELECTRIC MOTORS s.r.l.** offices and are only handled by specifically assigned staff.

If necessary, the data can be processed by the staff of the company responsible for the maintenance of the technological part of the site, TEM Electric Motors (data controller in accordance with [article 29](#) of the Code regarding the protection of personal data), at the headquarters of that company.

### TYPES OF DATA

#### *Navigation Data*

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the communication protocols of the Internet.

This information is not collected to be associated with identified persons, but by their nature, could, through processing and association with data held by third parties, allow to identify the users.

This category of data includes IP addresses or domain names of computers used by users connecting to the site, *URI (Uniform Resource Identifier)* of requested resources, time of request, the method used to submit the request to the server, the file size obtained in response, the numerical code indicating the status of response from the *server* (successful, error, etc.) and other parameters regarding the operating system and computer environment of the user.

These data are used only to obtain anonymous statistical information about the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in

case of computer crimes against the site: except for this possibility, the data on web contacts are not maintained longer than seven days.

#### *Data provided voluntarily by the user*

The optional, explicit and voluntary sending of e-mails to the addresses listed on the site involves the acquisition of the sender's mail address, needed to reply to requests, as well as any other data included in the message.

Specific summary information will be progressively reported or displayed on web pages dedicated to particular services on demand.

#### *Cookies*

No personal user data is acquired from the site.

We do not use *cookies* to transmit information of personal nature, nor are used c.d. *cookies* of any kind, or systems for tracking users.

The use of s.c. session *cookies* (which are not stored permanently on users' computer and disappear when the browser is closed) is strictly limited to transmitting session identifiers (consisting of random numbers generated by the server) necessary to enable a safe and efficient exploration of the site.

The s.c. session *cookies* used in this site avoid the use of other technologies that could compromise the privacy of the users and not allow the acquisition of personal identification data.

### **OPTIONALITY OF DATA CONFERMENT**

Except what specified for navigation data, the user is free to provide personal data reported in modules "information and contacts" on the website. Their absence may make it impossible to fulfill the requests.

### **MODALITY OF TREATMENT**

Personal data are processed by automated tools for the time strictly necessary to achieve the purposes for which they were collected.

Specific security measures are taken to prevent data loss, misuse or improper and unauthorized access.

### **USER'S RIGHTS**

Subjects whose personal data refer to, have the right to obtain at any time confirmation of the existence of such data and to know the content and origin, verify its accuracy or request its integration or updating, or correction ([art. 7 of the Code regarding the protection of personal data](#)).

According to the same article one has the right to request cancellation, transformation into anonymous form or block of data in violation of the law, and oppose any case, for legitimate reasons, to their treatment.
